**Finance Committee Report- Finance Committee** met Tuesday, approved bills. We are 91% through the financial year and we have spent 84% we are still in good shape.

My whole tenure on the School Board has been with you as our Superintendent and leader. You have done a phenomenal job in my eyes. You have revitalized the school system and the community as well. Superintendent's Report – July 15 is the deadline for the Virtual Virginia for the 2021-2022 school year. July 20 will the Finance Meeting at 5 pm. July 22 is the School Board Meeting. August 6 is the deadline to accept bids for new elementary/middle school. August 11 – new teachers report and August 16 all teachers report back to school. School starts August 25, and that is based on recommendation of the principals.

**Instructional Report** – report on testing results in closed session.

Special Education/Nurse Report – Happy to answer any questions. 15% SPED students.

**Transportation/Maintenance Report** – had a great year in both departments. Meal deliveries – transportation has delivered over 250,000 meals. Maintenance – we have been blessed with 9 new light poles given to us by Dominion. Dominion will set them up for us. The lights are not free. Lights will cost around \$50,000 to \$60,000 to light both fields. Lights are LED white light not yellow.
